REGISTRAR: Bonzi concerns-see Commissioner's report

RECREATION: Karl submitted a written report. Special thank you and congratulations to Chowchilla for graduating 20 new Pre-f coaches.

COACHING: Mike submitted a written report highlighting his goals for this seasonal year. His observation at the coach's meetings was that the "Mercy Rule" and other rules for Spring League were positive.

ODP: No report

D7PP: Schedules are up on the system. They will be revisited after seeding. Diego feels that the scheduler is right on track even though it is difficult. The biggest problem is the loss of fields. Discussion was held on the lack of fields and why this is happening. Problems will be worked on after seeding. Games start on the 11th.

REFEREES: Two grade 9 referee courses have been held. Grade 9 courses are kind of a training ground for refs and they can only referee recreational games. There is no timeline for grade 9, they can go on to grade 8 or stay grade 9. Reminder that all refs must go through their assignor.

COMMISSIONER'S REPORT: Spring League fields is always a problem until teams find they have to travel. No fee increase for referees, same as last season. At the last Cal North BOD meeting, the concussion policy was brought up, need to start getting coaches to take the on-line course. Policy on leagues delinquent past 60 days will be adopted soon. Please pay your registration fees on time. CYSA DBA CAL NORTH was approved. The by law revision was withdrawn from the AGM. Problems with Bonzi/Blue Star have come up. John asked for a breakdown on what is covered under the contract with no response. Do not buy anything from Bonzi until you know what you are getting. Affiliations are in for all but two leagues. Rooms for Friday night before the AGM are available at a special rate.

OLD BUSINESS: Level 9 referee course is going as planned with two done so far. Once again a list of outstanding fines and registration fees was submitted. Reminder that John will pull teams from the Spring League if not paid.

NEW BUSINESS: D7 is offering to reimburse leagues attending the AGM for Friday night room only. Attendees must submit hotel receipts in order to be reimbursed.
