**REGISTRAR:** John explained the IT process and how it affects our leagues.

**TREASURER:** The treasurer reported that financial reports will be available at the next meeting. Apologies for not being able to present them at this meeting.

**CUPS:** Good luck to teams in State and President's Cups.

**ODP:** No report, no new information available.

**TOP SOCCER:** No report

**RECREATION:** Karl submitted a written report. Special thank you to Scott Biehl, who is a partner in FC Soccer, for providing a packet of 18 tickets to their first game. There will be future packets given. He explained the article attached to his report in the context that we are trying to specialize players in one sport rather than making them well rounded athletes as is done by Barcelona.

**D7PP:** Deadlines will be held firm for fall league. Field applications must be filled out properly. For Spring League, because of rain outs, extra games will be done. Discussion was held on the problems of scheduling and info between Bonzi and Got Soccer. If a request is made to reschedule one game, it affects 15 others.

**COACHING:** Be sure to get your F and E courses booked.

**REFEREES:** Pat submitted a written report. The new Grade 8 course replaces the old Grade 8 and Grade 9 courses and is 9 hours instead of 18. Courses are scheduled in Clovis, June 30 and July 14 and in Hanford July 14-15. Registration for 2019 will start in July.

**COMMISSIONER'S REPORT:** The Commissioner reminded everyone that there is an important meeting scheduled for May 19th and 20<sup>th</sup>. May 19<sup>th</sup> will be for workshops and May 20<sup>th</sup> will be the rescheduled AGM. He explained that PDI is mandatory and explained why the ball size and age group makes a difference for the player. He stressed the importance of rostering players in their own age group.

**OLD BUSINESS:** The Visalia Tournament was approved by Cal North, not by District VII. It is restricted to teams from Cal North Only. Teams who wish to enter must play their Spring League games. All playing rules must be followed, ie, mandated rest times, only two games per day, etc. It was recommended that the team not playing their regular league game shall be fined \$300.

Approval of Fall and Spring League forms was brought forth. After discussion on verbiage and entry fees, the following motion was made.
