REPORTS

REGISTRAR: John reported that the registrars had a meeting with Shirley. The CYSA committee is looking into a different program for registration.

TREASURER: The treasurer reported that she got an e-mail from the state saying that they are still doing the audit. The fall playing league report was included in all mail boxes.

CUPS: John stated that a Nor Cal team played in one of our cups even though they have not played in any of our leagues. He will check with CYSA to see why this was allowed. A list of winners and finalists from the State and President's cups was given to all leagues.

RECREATION: Karl attended the AGM and sat in on the Referee's course. They are working on the problems with the touch line. He introduced Catarino Garcia, D7 COY. He asked Catarino to give an account of his experiences. Catarino stated that he became a coach because his kid's coach quit and they had no one to take the team. He loves coaching and intends to go until U-19s. Because he comes from a small league, he asked for help in recruiting more players and how to secure fields. Karl suggested that we should have a workshop on those topics.

COACHING: Mike has an agenda item under old business.

D7PP: Diego says everything is going quite well. Large Park puts notes on the game cards which is really appreciated.

REFEREES: Pat submitted a written report. There is a referee course being held in Hanford on July 12/13. Balance of his report is under Good of the Game.

COMMISSIONER'S REPORT: John reported that there were only two items to be voted on, one passed, one didn't. He is still working on arrangements for the May District meeting. Reminder that Tournament Travel Notification is needed for all non-USYS sanctioned events sanctioned by U S Soccer affiliates. He initiated discussion on the serving of Red Cards at a non-sanctioned CYSA event.
