REPORTS

REGISTRAR: John reported that Stack Sports is working on the transition to Affinity. He had a list of non-payments of registration fees and asked that all leagues please pay.

TREASURER: The District financials have been sent to the state.

CUPS: John reported that an official from CYSA was trying to change a team application from Association to State Cup.

RECREATION: Karl submitted a written report.

COACHING: No Report

D7PP: Ann submitted a written report and highlighted the problem with Upper Age brackets and CIF rules. Discussion was held on CIF moving their “season” up a week each year, that other organizations, US Club, don’t comply but CYSA must. Diego would like to meet with CIF to discuss and clarify the situation. She also reported on District Cup, number of entries and game sites.

REFEREES: Pat said that there are problems with the new format. If an entrant in the course passes the course, he/she will not get their badge because of the rule that referees must get a live scan before they are eligible. Sometime the live scan approval can take up to two weeks or longer. The rule states that every ref over the age of 18 must get a live scan. If you wish to hold a course make sure you include the date, time, location and inform the entrants to get a live scan.

COMMISSIONER: Certificate of liability forms were given to everyone. John explained the changes to the registration fees. US Soccer raised their fees to the state which prompted CYSA to raise their fees. District 7 voted no due to fees and the budget. CYSA passed a budget with a huge deficit. He wants to give the vote on fees back to the membership. No confirmation of the date of the AGM. There are problems with sidelines, referee and player allegations of assault. He is investigating. He gave a rundown on how to build the league's player registration numbers. The state has lost approximately 65,000 players.

OLD BUSINESS: Make sure your meeting fines are paid. The Kerman agenda item has been resolved. Affirmation of Spring League Rules and fees was brought forth. Addition to the Application to Host to include the following:
