

DISTRICT VII MEETING 8/11

August 11, 2021

The Commissioner brought the meeting to order at 7:31 P.M.

Minutes: *Motion to approve the minutes of July 14, 2021.* *Unanimous*

REPORTS

Registration: The registrar's e-mail is not working. John suggests that the e-mail questions be sent to him and please be patient. D7 has almost 5500 players registered and some are just starting. Do not use the old forms for live scans. There are 5 sites for Capital Life Scans. He will try to get a list. Some of the forms will be adapted to one site, Safety & Health. John suggests that we charge \$5.00 per coach to pay for JDP.

Treasurer: Hopefully a new CYSA Treasurer will be hired. We have a temp now. No audit results.

Recreation: He would like to have articles from this District rather than the national ones. There is a new course for coaches. It is a three hour course, 1st hour is kids, 2nd hour is coaches and the 3rd hour is for questions. Question was asked about Karl's license level. He was up to National "A". He would teach the specifics to anyone that wants to help hold these courses. Feedback is that people want more videos.

Coaching: Mike brought up the concussion form.

There was a lively discussion between coaching and referees as to who is responsible if a child gets a head injury.

Referees: Pat said he has been getting calls. Referees must be at least 13 years old. Referees 18 years and older must have live scans. Interested parties must sign up with CNRA- cost is \$75.00. If a league wants to have a clinic, the cost is \$300. Field session is 3 hours. There is a class scheduled for Kerman.

D7PP: Diego reported that they could still use U-12 and U17 boys teams. Otherwise, everything is on track.

Proposal was made to allow guest players for the Recreational bracket. Guest players must be from the same league as the team's league of registration.

Motion made to approve M/S/C 11 Aye 1 Abstention

Commissioner's Report:: Got Sport training is being offered on line for the 2022/23 season. John is working on in-person training for D7. CYSA did not have in-person meeting but reverted to zoom. CYSA budget was presented as proposed. Discussion was held on future collection of player or coach's fees to cover JDP. New staff will be helping to streamline coach's live scans and JDP clearances. CYSA has moved to Sacramento.

New Business: Information only: Top Soccer event hosted by Clovis Crossfire. Lemoore CYSA tournament is approved for the end of September.
