May 10, 2023

The District Commissioner brought the meeting to order at 7:33 P.M.

MINUTES: M/S/C To approve the minutes of April 12, 2023

TREASURER: The treasurer stated that she was there to collect unpaid meeting fines. No response.

REGISTRATION: John stated that Visalia has over 30,000 students, but only 835 play CYSA soccer. We need to build up our numbers. We have 15,000 this year and need to register 16,000 for the coming year. When registrars get a survey, please answer.

RECREATION: Karl submitted a written report. The report included what is needed to request a D7 Coaching Course. Please send articles for Karl's comments.

COACHING: Please plan and schedule your District E Course.

REFEREES: Pat urged the leagues to schedule a GDF course. The only charge is mileage to the venue. Reedley is scheduled for August. Send the request directly to Pat. The courses CNRA does are preparations for State Cup, World Cup, etc. We need to start with our youth leagues. Reminder that the minimum for GDF Course is 10 and max is 16 and will accept boys and girls 13 and up, and adults. Adults must have a live scan done.

D7PP: Going well. Spring League has 2 more weekends to go. Biggest problem is that game cards and send-offs are not submitted in a timely manner. Please see that this is done. Reedley may have 4 new fields.

CUPS: No Report

OFFICE: List of fines due has been sent. Office fee billing has been sent to all leagues. Reminder that if you cannot make a meeting, you have 2 annual "get out of fine cards". If you wish to use the option, let Linda know or you will be billed.

COMMISSIONER'S REPORT: Cinco had to be cancelled for lack of entries. District boundaries will be discussed at the CYSA June meeting. Affiliations have been sent to CYSA including one conditional affiliate. According to CYSA's Strategic Plan, all Districts must give a number of expected players. We need to increase our numbers by 5% from the current 15,000+ to 16,000.
