## Eligibility

All teams considered for acceptance must be made up of players who are registered with and play on teams that are registered in District 7 and affiliated with CYSA (Cal North) during the 2024/25 season.

1. The teams must be an already formed team in the 2024/25 season.

2. The open division is for competitive registered teams and teams wishing to compete in CYSA State Cup or Junior Cup. If you win you will have the option of playing in your roster age group in State cup.

Team Rosters and players passes are required. Coaches shall have in their possession throughout the tournament the individual CYSA D7 player passes and must be made available along with the team roster at check in.

Guest players are not allowed

## **General Rules**

The tournament adheres to current D7 playing program rules. However, no protests shall be accepted.

Teams shall warm up off the field of play and be prepared to take the field to begin the game following completion of the previous game.

#### Games

U10 – 7 v 7. 20-minute halves. Ties will stand

U12 – 9 v 9. 25-minute halves. Ties will stand

U14 -11 v 11. 30-minute halves. Ties will stand

U16 - 11 v 11. 30-minute halves. Ties will stand

U19 - 11 v 11. 30-minute halves. Ties will stand

Championship games ending in a tie will be decided on penalty kicks.

The Home team is listed first on the schedule and is responsible for bringing a game card and game ball. The Home team will make the change in the event of a uniform color conflict. It is allowed for bibs to be worn if necessary.



## DISTRICT VII CUP 2024 - INFORMATION AND RULES

#### Substitutions

A substitution may be requested by either team prior to any ball going out of play.

An unlimited number of players may be substituted with the referee's permission.

No substitution is allowed for an ejected (red carded) player.

Any coach red carded shall be suspended from the field of play for the remainder of the tournament.

### Scoring

As per D7 Playing League rules: 3 points per win, 1 point per tie, 0 points per loss.

## Mercy rule

There is no mercy rule ruling in this tournament

## Flight Winners

This will be determined on the total points accumulated during the preliminary games. In the event of a tie within a flight, following the completion of the preliminary games, the flight winner will be determined by:

- Head to Head results
- Goal Differential (Total of Goals for minus Goals against to a maximum of 4 goals)
- Total of Least goals allowed
- Total of goals scored (Maximum of 4 per game)
- Penalty kicks as per FIFA

#### Awards

Winners of the **OPEN** Division will have all or part of their entry into Cal North State Cup paid, these teams will be eligible on winning State Cup to enter USYS President Cup or USYS State Cup representing Cal North in either Regionals.

#### **Entry Fees**

#### **Open Division**

U9 - U19 entry fee is \$550 per team.

#### District 7 Cup

U10-U12 entry fee is \$350.00 per team.

U14 – U19 entry fee is \$450.00 per team.

All fees should be made by League check or cashier's check/money order made out to CYSA District VII, on line registration **may** be available through Got Sport by going to the website and registering under District7Cup.

## **Application Deadline**

All applications must be received at the District VII office or on line no later than Friday October 18th.

### **Uniforms**

Teams participating in this tournament shall wear their League jerseys. In case of color conflict and bibs are needed the Home team shall wear the bibs.

Sweatpants are not allowed but long sleeves can be worn under the jersey so long as they are the same color as the jersey.
